Travel and Subsistence are paid at rates agreed within the Members Allowances Scheme. Members may claim costs when travelling on approved duties. The total amount of payment will vary from Member to Member depending on a number of factors. These factors include the distance that they live from the Police Authority to the Police Headquarters at Wymondham and the extent to which they are required to attend Local, Regional and National meetings on behalf of the Authority. Travel costs relate to payments made to the individuals and do not include expenditure arranged and paid for directly by the Police Authority.

Members Sundries includes taxis, car parks, reimbursement for overnight accommodation and ad hoc rail journeys (which have not been booked centrally).
